Subject: URGENT REQUEST FOR INTERVENTION – DENUNCIATION OF SWITZERLAND AS A MAFIA STATE – COMPLICITY OF RATING AGENCIES – CIVIL LIABILITY OF CHF 128'451.85 BILLION

THE GLOBAL ECONOMY IS IN DANGER DUE TO THE FAULT OF FRANCE AND SWITZERLAND, BUT ALSO THE USA! <https://swisscorruption.info/dossier>

M. President de la Fédération de Russie,

We have the honour to transmit herewith updated documents concerning the systemic collapse of the rule of law in Switzerland, the widespread corruption of its institutions, and the involvement of transnational criminal networks..

The evidence is now complete.

Our dossier documents:

1. **The fraud and money laundering of the FERRAYÉ royalties** (USD 3,700 billion in 1991-1992), with the active complicity of the Swiss authorities (MPC, TF, TPF, FINMA, FedPol, banks).
2. **The role of the French and Swiss governments** in this laundering, through agents such as Éric DE LAVANDEYRA (cf. letter from Marie Laforêt), the denunciations of Christine DEVIERS-JONCOUR (spouse of Minister Roland DUMAS at the time), and international and Swiss auditing firms (KPMG, Ernst & Young, Berney & Associés, etc.).

3. **The persecution of victims and whistleblowers** and the systematic obstruction of criminal proceedings for over 30 years.
4. **Switzerland's civil liability:** CHF 128,451.85 billion, representing more than 160 times its GDP.

The fraud and money laundering of the royalties has not only endangered Switzerland's economy, but that of the whole of Europe. In this context, Russia has paid a heavy price. We must together put an end to this and regain control of this laundering: <https://swisscorruption.info/le-parrain>

If Switzerland does not accept the offer we made to it on 1 June 2026 and does not comply by 6 August 2026 at the latest, we request your intervention as a permanent member of the UN Security Council to:

1. **Seize the Security Council** with a request for an official denunciation of Switzerland as a "mafia state".
2. **Inform the international community** of the systemic risks posed by Switzerland's imminent insolvency.

3. **Denounce the complicity of the rating agencies** which, by assigning a AAA rating to Switzerland, mislead investors and expose themselves to prosecution.

We inform you that, after the deadline of 6 August 2026, we will activate our civil reserves and we will seize the ECHR, GRECO, and the UN through your intermediary if you don't mind.

The rating agencies, which cannot ignore this situation, have been put on notice to act if the conditions of our offer are not fully accepted. You will find a copy of our démarche on this subject enclosed.

The time of omertà is over. If Switzerland does not become aware of its duties, it must fall to rise again clean.

We count on your support for the truth to be revealed internationally.
